16 At-Large Councilmember, Vincent Bernard Orange, Sr. introduced the following bill, which was  
17 referred to the Committee on \_\_\_\_\_.

18 To amend the District of Columbia Smoking Restriction Act of 1979 to prohibit smoking within  
19 25 feet of playground or play area located on a public or private educational facility or on  
20 a District of Columbia Parks and Recreation Center.

21 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this  
22 act may be cited as the “Smoking Restriction Amendment Act of 2013”.

23 Sec. 2. The District of Columbia Smoking Restriction Act of 1979, effective September  
24 28, 1979 (D.C. Law 3-22; D.C. Official Code § 7-1701 *et seq.*), is amended as follows:

25 (a) Section 3 (D.C. Official Code § 7- 1702) is amended by adding a new paragraph (4A)  
26 to read as follows:

27 “(4A) “Playground” or “Play area” means any outdoor area with equipment or devices  
28 intended to be used for play by minors, such as a:

- 29 (A) swing set;  
30 (B) sand box;  
31 (C) slide;  
32 (D) seesaw; or  
33 (E) play house.

1 (b) Section 4 (D.C. Official Code § 7- 1703) is amended by adding new paragraph (9) to  
2 read as follows:

3 “(9) Within 25 feet of a playground or play area located on a public or private educational  
4 facility or on a District of Columbia Parks and Recreation Center”.”

5 “(a) A residential home owner or tenant who resides within 25 feet of a playground or  
6 play area shall not be subject to this smoking restriction”.”

7 (c) Section 5 (D.C. Official Code § 7- 1704) is amended by adding a new subsection (b-  
8 1) to read as follows:

9 “(b-1) The owner, manager, or person in charge of a playground or play area shall  
10 conspicuously post at least 4 signs at the 25 foot boundary of the playground or play area stating  
11 that smoking is not permitted on the playground or play area.”

12 Sec. 3. Fiscal impact statement.

13 The Council adopts the fiscal impact statement in the committee report as the fiscal  
14 impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,  
15 approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

16 Sec. 4. Effective date.

17 This act shall take effect following approval by the Mayor (or in the event of veto by the  
18 Mayor, action by the Council to override the veto), a 30-day period of Congressional review as  
19 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December  
20 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of  
21 Columbia Register.
