1. **✓Bill 13-25, "Prevention of the Demolition of Historic Buildings by Neglect Amendment Act of 1999."** To prevent the demolition of historic structures by neglect through the establishment of minimum maintenance standards for historic properties in the District of Columbia. (Co-Introduced by Councilmembers Ambrose, Mendelson, and Evans) *Enacted as part of Title I of Law 13-281, the "Abatement and Condemnation of Nuisance Properties Omnibus Amendment Act of 2000"*
2. **Bill 13-26, "Income Tax Credit for Restoration and Rehabilitation Older Buildings Act of 1999."** To amend title 47 of the District of Columbia Code to provide a District of Columbia income tax credit for certain older buildings. (Co-Introduced by Councilmembers Ambrose, Mendelson and Evans)
3. **Bill 13-27, "Small Business Personal Property Tax Exemption Act of 1999."** To exempt from the tax imposed on personal property the personal property of any corporation or partnership with annual gross receipts of one million dollars or less. (Co-Introduced by Councilmembers Ambrose, Mendelson and Evans)
4. **✓Bill 13-28, "Policemen and Firemen's Retirement and Disability Amendment Act of 1999."** To amend the Policemen and Firemen's Retirement and Disability Act amendments of 1957 to increase the survivor annuity for a member of the Metropolitan Police Department or District of Columbia Fire and Emergency Medical Services Department killed in the line of duty to 100% of the member's salary at the time of his or her death. (Co-Introduced by Councilmembers Ambrose, Evans and Mendelson) *Enacted as Title XI of D.C. Law 13-172*
5. **Bill 13-31, "Taxicab Insurance Amendment Act of 1999."** To amend the District of Columbia Taxicab Commission Establishment Act of 1985 to permit all insurers authorized to sell motor vehicle insurance in the District of Columbia to offer insurance coverage to taxicabs. (Co-Introduced by Councilmembers Catania and Mendelson)
6. **Bill 13-32, "51% District Residents New Hires Amendment Act of 1999."** To amend the First Source Employment Act and the Washington Convention Center Act to impose penalties on contractors who fail to comply with the requirement that 51% of the new hires shall be District residents. (Co-Introduced by Councilmembers Catania and Mendelson)
7. **Bill 13-60, "Enforcement of the Prohibition of Tobacco Product Sales to Minors Act**

of 1999." To amend An Act to prohibit the sale of tobacco to minors under sixteen years of age in the District to increase the fines for sale of tobacco to minors for the first and subsequent offenses, to prohibit self-service displays and certain advertisements that encourage the illegal sale of tobacco products to minors and establish fines for first and subsequent offenses, to provide for a private right of action to enforce the provisions of this act, and to authorize the Department of Health to conduct random inspections of retail establishments that sell tobacco products; and to amend Title 47 of the District of Columbia Code to prohibit tobacco sales by vending machine and establish fines for the first and subsequent offenses. (Co-Introduced by Chairman Cropp and Councilmember Mendelson)

8. **✓Bill 13-83, "Safe Teenage Driving Amendment Act of 1999."** To amend the District of Columbia Traffic Act of 1925 and Chapter 1 of Title 18 of the District of Columbia Municipal Regulations; to establish a three-tired graduated driver's license program for youths 21 years of age or less; to establish night-time driving restrictions and passenger limits for drivers 18 years of age or less; and to require certified driving experience and demonstrated safe driving habits prior to the removal of driving restrictions. (Co-Introduced by Councilmembers Patterson, Mendelson, Allen, Ambrose, Chavous, Graham, Jarvis, Orange, and Chairman Cropp) *Enacted as D.C. Law 13-73*
9. **Bill 13-94, "Extension of the Moratorium on Retail Service Station Conversion and Gas Station Advisory Board Amendment Act of 1999."** To amend the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail stations until October 1, 2003, and to extend the life of the Gas Station Advisory Board. (Co-Introduced by Chairman Cropp and Councilmember Mendelson) *See Bill 13-409*
10. **✓Bill 13-140, "District of Columbia Board of Real Property Assessments and Appeals Membership Simplification Act of 1999."** To amend the District of Columbia Board of Real Property Tax Act Revision Act of 1974 to simplify the membership requirements on the Board of Real Property Assessments and Appeals. (Co-Introduced by Councilmembers Mendelson and Evans) *Enacted as D.C. Law 13-55*
11. **✓Bill 13-141, "Prohibition Against the Use of Social Security Numbers Act of 1999."** To amend the District of Columbia Traffic Control Act of 1925 and the Uniform Classification and Commercial Driver's License Act of 1990, to prohibit the Mayor from using social security numbers as identification numbers for driver's licenses. (Introduced by Councilmember Mendelson) *Enacted as D.C. Law 13-74 (renamed "Choice of Drivers License Number Amendment Act of 1999")*
12. **✓Bill 13-142, "Elections Amendment Act of 1999."** To amend An Act To regulate the election of delegates representing the District of Columbia to national political conventions, and an Act To fix and regulate the salaries of teachers, school officials, and other employees of the board of education of the District of Columbia, to allow minority party presidential candidates automatic access to the ballot and to require the candidates for the board of educa-

tion be residents of the District of Columbia for 1 year. (Introduced by Councilmember Mendelson) *Enacted in part as D.C. Law 13-78, and in part as D.C. Law 13-149*

13. ✓**Bill 13-168, "O Street Wall Restoration Act of 1999."** To require that the Mayor of the District of Columbia take certain actions to repair the Square S-5542, S.E. retaining wall. (Co-Introduced by Councilmembers Mendelson and Chavous) *Enacted as Emergency Act 13-68; Temporary as D.C. Law 13-29; Permanent Enacted as Title XV of D.C. Law 13-38*
14. **Bill 13-243, "Corporation Counsel Qualification Amendment Act,"** To set forth qualifications required of the Corporation Counsel of the District of Columbia. (Co-Introduced by Councilmembers Patterson, Mendelson, Allen, Ambrose, Catania, Chavous, Graham, and Schwartz)
15. **Bill 13-244, "Federal Conformity Tax Amendment Act,"** To amend the District of Columbia tax code to conform with federal law. (Co-Introduced by Councilmembers Mendelson, Allen, Brazil, Graham, Patterson, and Chairman Cropp)
16. ✓**Bill 13-263, "Tax Increment Financing Amendment Act,"** To amend the Tax Increment Financing Authorization Act of 1998 to expand the scope of priority development area, to authorize a greater portion of available real property tax revenues to be available to support tax increment financing bonds, and to create a housing development fund from tax increment financing bond proceeds to promote housing construction. (Co-Introduced by Councilmembers Evans, Mendelson, Ambrose and Catania) *Enacted as D.C. Law 13-128*
17. ✓**Bill 13-266, "Needlestick Prevention Act of 1999,"** To prohibit the use of "sharps" or needles without an engineered mechanism for limiting sharps injuries, to require that needles incidents be reported, and to provide penalties for failure to comply with the act, and this act is nonseverable. (Co-Introduced by Councilmembers Mendelson, Catania, Graham and Patterson) *Renamed "Safe Needle Act of 2000"; enacted as D.C. Law 13-272*
18. ✓**Bill 13-277, "Steve Sellow Street, N.W. Designation Act of 1999,"** To designate the 900 block of Varnum Street, N.E. as Steve Sellow Street, N.E. (Ward 5) (Introduced by all Councilmembers) *Enacted as D.C. Law 13-174*
19. ✓**Bill 13-287, "Designation of Dennis Dolinger Memorial Park Act of 1999,"** To symbolically designate the triangular park at the intersection of 15th St., S.E., G St. S.E., and Potomac Ave., S.E., Resv. 255-n, in Ward 6, as the Dennis Dolinger Memorial Park. (Introduced by all Councilmembers) *Enacted as D.C. Law 13-108*
20. ✓**Bill 13-332, "Tobacco Settlement Model Act of 1999,"** To require tobacco product manufacturers who are not participating in the Master Settlement Agreement to establish a reserve fund to guarantee a source of compensation for the District of Columbia under the agreement. (Introduced by Councilmembers Mendelson, Allen and Chairman Cropp) *Emergency Acts 13-109, 13-139; Temporary D.C. Law 13-45; Permanent D.C. Law 13-139*
21. ✓**Bill 13-333, "Physicians Negotiation Act of 1999,"** To allow for collective negotiation

by competing physicians of certain terms and conditions of contracts with health plans. (Introduced by Councilmembers Mendelson, Allen and Jarvis) *Adopted as Act 13-374; disapproved by Control Board*

22. ✓ **Bill 13-362, "Moratorium Amendment Act of 1999,"** To amend Title 23 of the District of Columbia Municipal Regulations (Alcoholic Beverages and Food) to allow for a moratorium on amended licenses in one or more of the specific categories of substantial change listed in 23 DCMR Section 505.3 for those geographical areas that already possess a moratorium on the number of licenses in any class. (Introduced by Councilmembers Evans, Mendelson and Chavous) *Enacted as §25-321 of D.C. Law 13-298 (Bill 13-449)*
23. ✓ **Bill 13-402, "District of Columbia Municipal Regulations Publication Improvement Amendment Act of 1999,"** To amend the District of Columbia Administrative Procedure Act of 1979 to provide for the regular compilation of complete and current versions of the District of Columbia Municipal Regulations (DCMR), to require that an electronic version of the DCMR be made available through the internet, and to provide that the Mayor may enter into agreement with private contractors of database services to offer electronic version(s) of DCMR. (Introduced by Councilmembers Schwartz, Mendelson, and Catania) *Enacted as D.C. Law 13-232*
24. ✓ **Bill 13-405, "The Choice in Drug Treatment Act of 1999,"** To provide a client seeking substance abuse treatment with a choice of treatment provider and a guarantee of service. (Introduced by all Councilmembers) *Enacted as D.C. Law 13-146*
25. ✓ **Bill 13-409, "Retail Service Station Amendment Act of 2000,"** To amend the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail stations until October 1, 2003 and to extend the life of the Gas Station Advisory Board. (Introduced by Councilmembers Allen, Mendelson and Chairman Cropp) *Extended until October 1, 2005 & Enacted as D.C. Law 13-130*
26. ✓ **Bill 13-449, "Title 25, DC Code Enactment and Related Amendments Act of 1999,"** To enact and amend title 25 of the District of Columbia Code; to amend the District of Columbia Comprehensive Personnel Act of 1978 to adjust the compensation payable to the members of the Alcoholic Beverage Control Board; and to amend the Alcoholic Beverage Control and Rules Reform Amendment Act of 1994 to repeal a regulation. (Introduced by Councilmembers Ambrose, Mendelson, Catania, Graham, and Chairman Cropp) *Enacted as D.C. Law 13-298*
27. ✓ **Bill 13-469, "School Governance Charter Amendment Act of 2000,"** To amend Section 495 of the District of Columbia Self-Government and Governmental Reorganization Act of 1973 to decrease the number of members of the District of Columbia Board of Education from 11 to 9, to alter the manner in which the members of the Board are elected, to provide for the election of the President of the Board of Education, and to clarify the role and obligations of the Board of Education and to make conforming changes to applicable

statutes. (Introduced by Councilmembers Chavous, Mendelson, Ambrose, Allen, Catania, Evans, Graham, Schwartz and Chairman Cropp) *Enacted in substantially different form as D.C. Law 13-159*

28. **✓Bill 13-484, "Water and Sewer Authority Collection Enhancement Amendment Act of 1999,"** To amend title 47 of the District of Columbia Code and the Clean Hands Act to require the payment of water and sewer bills as a condition to receiving a master business license or other license or permit; to amend the District of Columbia Public Works Act of 1954 to strengthen the receivership provision when water and sewer fees are unpaid; and to otherwise create penalties for the nonpayment of water and sewer bills. (Introduced by Councilmembers Mendelson, Graham and Schwartz) *Enacted as D.C. Law 13-183*
29. **✓Bill 13-485, "District of Columbia Conflict of Interest Amendment Act of 1999,"** To amend the District of Columbia Campaign Finance Reform and Conflict of Interest Act of 1974 to prohibit a member of a District board or commission from being appointed to any paid position under the supervision of that same board or commission unless the member has been separated from the board or commission for 90 days and unless that former member has complied with the same application process required of other applicants. (Introduced by Councilmember Mendelson) *Enacted as D.C. Law 13-184*
30. **✓Bill 13-577, "Rental Housing Act Extension Amendment Act of 2000,"** To amend the Rental Housing Act of 1985 to extend the sunset provision to December 31, 2004. (Introduced by Councilmembers Mendelson, Chavous, Evans, Graham, Patterson, Schwartz and Chairman Cropp) *Enacted as Title XII of D.C. Law 13-172 (extension to 2005)*
31. **✓Bill 13-586, "Tax Clarity Act of 1999,"** To amend various provisions of the tax code for purposes of simplification, ease of administration, and clarity. (Introduced by Councilmembers Evans, Mendelson, Catania, and Jarvis) *Renamed "Tax Clarity Act of 2000"; Enacted as D.C. Law 13-305*
32. **✓Bill 13-609, "District of Columbia Soil and Water Conservation Amendment Act of 2000."** to amend the District of Columbia Soil and Water Conservation Act of 1982 to allow residents who are not ANC commissioners to serve on the Citizen's Advisory Committee. (Introduced by Councilmembers Mendelson and Allen) *Enacted as D.C. Law 13-235*
33. **✓Bill 13-632, "Fair Phone Charges for Prisoners Act of 2000."** To provide limits on the amount which can be charged for telephone calls by District of Columbia inmates or by inmates in penal institutions located in the District of Columbia. (Introduced by Councilmembers Mendelson and Graham) *Enacted as D.C. Law 13-280*
34. **Bill 13-633, "Miranda Codification Act of 2000."** To codify the "Miranda Warnings" in the District of Columbia and to require that custodial interrogations be recorded. (Introduced by Councilmember Mendelson)

35. **Bill 13-634, "Misdemeanor Jury Trial Act of 2000."** To require that trials where the cumulative maximum penalty is more than 180 days and/or \$1,000 fine be jury demandable; and to require that a jury determine non-jury demandable offenses where they are deciding jury demandable offenses at the same trial. (Introduced by Councilmembers Mendelson, Allen, and Chavous)
36. **Bill 13-635, "Dishonored Check Act of 2000."** To provide the sellers of goods or services with a right of action against a drawer of a check (or other money instrument) when the drawer fraudulently negotiates the check in order to obtain goods or services and the check is subsequently dishonored. (Introduced by Councilmembers Mendelson and Evans)
37. **Bill 13-636, "Anti Forced Labor Amendment Act of 2000."** To amend the Procurement Practices Act of 1985 to require that contractors certify that no foreign made goods produced by forced labor are supplied by the contract. (Introduced by Councilmembers Mendelson and Graham)
38. **✓Bill 13-637, "The Health Care Expansion Act of 2000."** To expand Medicaid coverage to cover childless adults ages 19-27 with incomes below 50% of poverty, childless adults ages 50-64 with incomes below 100% of poverty; to provide Medicaid coverage to persons testing HIV positive; and to reform the D.C. Medicaid eligibility determination and enrollment process to facilitate the enrollment of eligible participants. (Introduced by Councilmembers Allen, Mendelson, Catania, Graham, and Schwartz) *Enacted as D.C. Act 13-569*
39. **✓Bill 13-679, "Risk Management for Settlements and Judgments Amendment Act of 2000" & "Multiyear Budget Plan Act of 2000"** (titles 43 & 44 of the Fiscal Year 2001 Budget Support Act of 2000). Title 43 amends An Act Authorizing the Commissioners of the District of Columbia to settle claims and suits against the District of Columbia to direct the Mayor to pay certain settlements from current fiscal year agency operating budgets. Title 44 requires five agencies or programs (the Commission on Mental Health, Child and Family Services, special education services provided to the District of Columbia Public Schools (including services provided under the LaShawn receivership), the Settlements and Judgments Fund administered by the Corporation Counsel, and homeless services provided by the Department of Human Services) to submit a multiyear financial plan to the Council. (Introduced by Councilmember Mendelson) *Enacted as part of D.C. Law 13-172*
40. **✓Bill 13-671, the "Tenant Protection Amendment Act of 2000."** To amend the Rental Housing Act of 1985 and the Rental Conversion and Sale Act of 1990 to preserve tenant rights if a building has been closed by the District of Columbia for housing code violations by providing that the tenancy shall continue for two years after physical occupancy ceases for purposes of preservation of tenancy rights and rights relating to sale or conversion and reoccupancy. (Introduced by Councilmembers Graham, Mendelson, Ambrose, Evans, and Schwartz) *Emergency enacted as D.C. Act 13-328; Temporary as D.C. Law 13-158; Permanent as Title 3 of D.C. Law 13-281, the "Abatement and Condemnation of Nuisance Properties Omnibus Amendment Act of 2000"*

41. ✓ **Bill 13-751, the "Equity in Contracting Amendment Act of 2000."** To amend the Procurement Practices Act of 1985 to require the Auditor to prepare an annual report on selected privatization contracts, along with a determination as to whether the contracts are meeting cost saving and performance targets; and to require the Mayor to make a determination and findings about the merits of contracting in for goods and services when the Auditor has determined that a privatization contract is not meeting cost saving or performance targets. (Introduced by Councilmembers Patterson and Mendelson) *Enacted as D.C. Law 13-274*
42. ✓ **Bill 13-794, the "Nurse's Rehabilitation Program and Committee Act of 2000."** To establish a rehabilitation program and committee for impaired nurses licensed in the District of Columbia. (Introduced by Councilmembers Allen and Mendelson) *Enacted as D.C. Law 13-297*
43. ✓ **Bill 13-850, the "District of Columbia Health and Hospitals Public Benefit Corporation Emergency Amendment Act of 2000."** (Temporary is Bill 13-855) To ensure that two major changes that would eliminate or decrease the services formally provided by the D.C. General Hospital -- transition from a full-service, acute-care hospital to a community-access hospital, or the removal or termination of the Level-1 trauma center -- be submitted to the Council for a 45-day period of review. (Introduced by Councilmember Mendelson) *Enacted as emergency D.C. Act 13-454; temporary as D.C. Act 13-479; Repealed by Control Board*

1. ✓ **PR 13-130, "Council Opposition to Amendment of Existing Slot Rule and Perimeter Rule at Ronald Reagan Washington National Airport Resolution of 1999,"** To express opposition to certain provisions of Senate Bill 82, "The Air Transportation Improvement Act" that would amend the existing slot rule and perimeter rule at Ronald Reagan Washington National Airport. (Introduced by all Councilmembers) *Adopted as R 13-93*
2. **PR 13-131, "Sense of the Council on the Construction of a Correctional Facility Location and Community Preservation Resolution of 1999,"** To declare the sense of the Council on the construction of a private correctional facility on existing parkland on Oxon Cove, in Ward 8. (Introduced by Councilmember Mendelson) *Rendered moot by Zoning Commission decision to reject the application of Corrections Corporation of America*
3. ✓ **PR 13-141, "O Street Wall Restoration Emergency Declaration Resolution of 1999,"** To Declare the existence of an emergency regarding the need to prevent further deterioration, by soil erosion and sedimentation, of certain public and private properties near the O Street Wall. (Introduced by Councilmembers Mendelson and Chavous) *Adopted as R 13-111*
4. ✓ **PR 13-320, "Tobacco Settlement Emergency Declaration Resolution of 1999,"** To declare the existence of an emergency with respect to the need to enact model legislation to implement the Tobacco Master Settlement Agreement. (Introduced by Councilmembers Mendelson, Allen and Chairman Cropp) *Adopted as R 13-173*

5. **✓PR 13-460, "Tobacco Settlement Model Act of Congressional Review Emergency Declaration Resolution of 1999,"** To declare the existence of an emergency due to Congressional review regarding the enactment of model legislation to implement the Tobacco Master Settlement Agreement. (Introduced by Councilmember Mendelson)
Adopted as R 13-261
6. **✓PR 13-639, "Sense of the Council to Support the Creation of a Circulator Bus by the Downtown Business Improvement District Resolution of 2000,"** To declare the Sense of the Council in support of a circulator bus system to relieve the Mall area of overcrowding, increase commercial activity and retail sales in the city, and improve DC neighborhood exposure to visitors. (Introduced by all Councilmembers) *Adopted as R 13-432*
7. **PR 13-694, "Contract for the Installation of the District's Comprehensive Automated Payroll and Personnel Systems (CAPPS) Phase II Disapproval Resolution of 2000,"** To disapprove the contract for the Installation of the District's Comprehensive Automated Payroll and Personnel System (CAPPS) Phase II. (Introduced by Councilmembers Patterson, Mendelson, Allen, Ambrose, Catania, Chavous and Evans)
8. **PR 13-720, "Sense of the Council Resolution Supporting a Regional Attack on Motor Vehicle Theft,"** To declare the sense of the Council on the formation of a Washington Area Vehicle Enforcement tactical team to combat motor vehicle theft in the District of Columbia and the Washington Metropolitan region. (Introduced by Councilmembers Mendelson and Schwartz) *Implemented by MPD without passage of this resolution*
9. **✓PR 13-766 & PR 13-767, "Sense of the Council Opposition to the Attorney General of the United States Seeking the Death Penalty for Crimes Committed in the District of Columbia Emergency Declaration Resolution of 2000" and "Sense of the Council Opposition to the Attorney General of the United States Seeking the Death Penalty for Crimes Committed in the District of Columbia Emergency Resolution of 2000."** To request as the sense of the Council that the U.S. Attorney General not seek the death penalty for crimes committed in the District of Columbia. (Introduced by Chairman Cropp and Councilmembers Mendelson, Allen, Ambrose, Chavous, Evans, Graham, Jarvis, and Patterson) *Adopted as R 13-511 & R 13-512*
10. **✓PR 13-768, "Council of the District of Columbia's Mental Retardation and Developmental Disabilities Administration Investigation Authorization Resolution of 2000."** To authorize an investigation by the Council into the circumstances surrounding the status of the Mental Retardation and Developmental Disabilities Administration. (Introduced by all Councilmembers) *Adopted as R 13-513*
11. **✓PR 13-790, "Tenant Protection Emergency Declaration Resolution of 2000."** To declare the existence of an emergency with respect to the need to amend the Rental Housing Act of 1985 and the Rental Conversion and Sale Act of 1990 of the District of Columbia so that the owners of buildings that are closed by the District of Columbia as unfit for human habitation are not rewarded by their inaction. (Introduced by Councilmembers Graham, Mendelson, Ambrose, Evans, and Schwartz) *Adopted as R 13-524*

12. **PR 13-883, "Sense of the Council in Support of Litigation Challenging the Constitutionality of the Congressional Prohibition on the District's Ability to Tax All Income Earned Within District Borders Resolution of 2000."** The prohibition discriminates against District residents who are not represented in Congress and in favor of non-residents who are represented in Congress, and it discriminates against the unrepresented District by taking away its right to tax persons receiving the benefit of District services." (Introduced by all Councilmembers)
13. **✓PR 13-988, "Sense of the Council on Federal Agency Compliance with Certain District of Columbia Contracting and Procurement Laws Resolution of 2000."** To declare the sense of the Council that Congress and the President require federal agencies to comply with certain District of Columbia contracting and procurement laws when the agencies act for or on behalf of the District of Columbia. (Introduced by all Councilmembers) *Adopted as R 13-696*
14. **✓PR 13-1014, "Tri-Jurisdiction Joint Legislative Commission on Interstate Transportation Resolution of 2000."** To authorize the Chairman of the Council of the District of Columbia to select District representatives to the Tri-Jurisdiction Joint Legislative Commission on Interstate Transportation which shall advise the Council of the District of Columbia and the Mayor on efforts to address interstate transportation issues in the Washington metropolitan region. (Introduced by Councilmembers Mendelson and Schwartz) *Adopted on an emergency basis (PR 13-1057) as R 13-682*
15. **✓PR 13-1042, the "District of Columbia Health and Hospitals Public Benefit Corporation Emergency Declaration Resolution of 2000."** To declare the existence of an emergency with respect to the need to require Council approval for any restructuring of the D.C. General Hospital by the District of Columbia Health and Hospitals Public Benefit Corporation which results in closing the Level-1 trauma center or a significant change in its status as a full-service, acute-care hospital. (Introduced by Councilmember Mendelson) *Adopted as R 13-672*
16. **✓PR 13-1056, the "Tri-Jurisdiction Joint Legislative Commission on Interstate Transportation Emergency Declaration Resolution of 2000."** To declare the existence of an emergency with respect to the need for the District of Columbia to make timely appointments to the Tri-Jurisdiction Joint Legislative Commission on Interstate Transportation. 1. **✓CER 13-287, "Capitol Area Food Bank Recognition Resolution of 2000."** To recognize the Capital Area food Bank's twenty year history of feeding those who suffer from hunger, and to honor its goal of eliminating hunger in the District of Columbia in the Washington metropolitan area through the education, empowerment, and enlightenment of the community about the issues of hunger and nutrition. *Adopted as ACR 13-287*

2. ✓**CER 13-344, "National Parents Day Recognition Resolution of 2000."** To recognize the important role parents play in our community and to honor the seventh anniversary of "National Parents Day" on Sunday, July 23, 2000. *Adopted as ACR 13-344*
