

**LEGISLATION INTRODUCED / CO-INTRODUCED BY  
COUNCILMEMBER MENDELSON**

**Council Period XVI**

1. **✓Bill 16-12, “Omnibus Utility Emergency Amendment Act of 2005.”** To enact on an emergency basis Bill 15-872 (the Omnibus Utility Amendment Act of 2004) except for the provisions relating to underground telephone/telegraph conduit. *Adopted as D.C. Act 16-12*
2. **✓Bill 16-25, “Anacostia Waterfront Corporation Board Expansion Amendment Act of 2005.”** To increase by two membership on the Anacostia Waterfront Corporation Board to include public citizen members who shall be a representative of a recognized labor union and a representative of a recognized environmental organization. Co-introduced by Councilmembers Ambrose, Mendelson, Evans, and Patterson. *Adopted as D.C. Act 16-119*
3. **✓Bill 16-47, Rental Housing Act Extension Amendment Act of 2005.”** To extend the sunset provision to December 31, 2010. Co-introduced by Councilmembers Graham, Mendelson, Barry, Brown, Evans, Fenty, Gray, Patterson, Schwartz, and Chairman Cropp. *Adopted as D.C. Law 16-10*
4. **✓Bill 16-50, Rental Housing Conversion and Sale Amendment Act of 2005.”** To provide tenants with an opportunity to exercise first right of refusal to purchase their housing accommodation when there is a transfer by the owner of a controlling interest in the property within a 12 month period. Co-introduced by Councilmembers Mendelson, Fenty, and Graham. *Adopted as D.C. Law 16-15*
5. **Bill 16-51, “Rent Control Statute of Limitations Amendment Act of 2005.”** To allow tenants to challenge all adjustments to the rent ceiling. Co-introduced by Councilmembers Mendelson, Fenty, and Graham. *Rendered moot by final action on Bill 16-109.*
6. **✓Bill 16-52, “Domestic Partnership Equality Act of 2005.”** To grant domestic partners similar rights and responsibilities currently held by spousal couples in the areas of spousal immunity, inheritance, surviving spouses and children, spousal support, and public assistance.
7. **Bill 16-53, Taxicab Insurance Amendment Act of 2005.”** To increase the minimum standards of insurance coverage for taxicabs, and to allow taxicab insurance to be sold by non-

admitted companies through brokers licensed pursuant to the Fire and Casualty Act. Co-introduced by Councilmembers Mendelson, Ambrose, Catania, and Gray.

8. **Bill 16-54, “Automated Traffic Enforcement Amendment Act of 2005.”** To require the Mayor to reevaluate the speed limits on streets or street segments where speed limit enforcement by automated camera is being utilized or proposed, and to require that any finds from automated speed camera enforcement be allocated to the Highway Trust Fund.
9. **✓Bill 16-55, “Dishonored Check Act of 2005.”** To provide the sellers of goods or services with a right of action against a drawer of a check (or other money instrument) when the drawer fraudulently negotiates the check in order to obtain goods or services and the check is subsequently dishonored. (Co-introduced by Councilmembers Mendelson, Ambrose, Catania, Evans, and Graham)
10. **✓Bill 16-56, “Vehicle Insurance Enforcement Act of 2005.”** To authorize law enforcement officers to demand proof of insurance from motorists and to require MPD officers to note insurance information in police reports of accidents; to require insurance companies to provide proof of insurance to D.C. motorists they insure, and to require motorists to produce proof of insurance on demand by law enforcement personnel, and for other purposes.
11. **✓Bill 16-57, “Charter School Founders Preference Act of 2005.”** To give a preference in admission to the children of those who found new charter schools, so long as enrollment of founders’ children is limited to no more than 10% of the school’s total enrollment or to 20 students, whichever is less. *Adopted as part of Bill 16-624*
12. **✓Bill 16-79, “Terrorism Prevention in Hazardous Materials Transportation Act of 2005”** (see also, emergency and temporary versions, **Bills 16-77 & 16-78**). To prohibit large shipments of certain extremely hazardous materials near the United States Capitol in order to reduce the risk of attacks by terrorists; to allow for the issuance of permits authorizing such shipments in special cases; and to require the Mayor to issue regulations to implement the provisions of this act. (Emergency co-introduced by Councilmembers Patterson, Mendelson, and Ambrose; permanent co-introduced by Councilmembers Patterson, Mendelson, Ambrose, Barry, Brown, Cropp, Evans, Fenty, Graham) *Emergency adopted as Act 16-43, temporary as D.C. Law 16-2, and permanent adopted as D.C. Law 16-80.*
13. **✓Bill 16-103, “Homeless Services Reform Act of 2005.”** To reaffirm the District’s commitment to address the problem of homelessness; establish an Interagency Council on Homelessness; to describe a continuum of care for individuals and families who are homeless or at imminent risk of becoming homeless; to codify the rights and responsibilities of clients of homeless services providers, and the standards by which the District and providers must deliver services to clients; and to revise the procedures for resolving disputes between clients and providers of homeless services. (Co-introduced by Councilmembers Fenty, Mendelson, Barry, Brown, Cropp, Evans, Graham, Gray, and Patterson ) *Adopted as D.C. Act 16-169*
14. **✓Bill 16-106, “Displaced Workers Protection Amendment Act of 2005.”** To add security guards to the occupational class protected by the Displaced Workers Protection Act of 1994,

and to make other changes to that law (D.C. Law 10-105). (Co-introduced by Councilmembers Brown, Mendelson, Barry, Evans, Fenty, and Schwartz) *Amended to simply add security guards (except DCPS), and attached to Bill 16-286, the Way To Work Amendment Act of 2006 (D.C. Act 16-335)*

15. ✓ **Bill 16-109, “Tenants’ Rights to Information Act of 2005.”** To amend the Rental Housing Act of 1985 to mandate full disclosure of pertinent information regarding rental properties, allowing tenants to make informed housing decisions. (Co-introduced by Councilmembers Patterson, Mendelson, and Graham) *Renamed “Rent Control Reform Amendment Act of 2006”; see Bill 16-457; adopted as D.C. Act 16-xxx*
16. **Bill 16-116, “HIV Unique Identifier System Amendment Act of 2005.”** To prohibit the use of social security numbers and country of origin as part of the Unique Identifier System for human immunodeficiency virus (HIV) cases and to require that information on transgender status be collected. (Co-introduced by Councilmembers Evans, Mendelson, Ambrose, Catania, Fenty, and Graham) *Rendered moot by directives from U.S. Centers For Disease Control*
17. ✓ **Bill 16-117, “Other Tobacco Products Tax Amendment Act of 2005.”** To establish a 15% excise tax on all non-cigarette tobacco products. (Co-introduced by Councilmembers Mendelson, Patterson, and Schwartz)
18. **Bill 16-118, “Exploratory Committee Amendment Act of 2005”** (emergency Bill **16-183**). To amend the District of Columbia Campaign Finance Reform and Conflict of Interest Act to make exploratory committees subject to campaign finance laws, and to subject contributions to such committees to the limits otherwise established for the office sought. (Co-introduced by Councilmembers Mendelson, Ambrose, Fenty, and Schwartz)
19. **Bill 16-119, “Parking Amendment Act of 2005.”** To permit the removal of motor vehicles parked in the front yard on private property when in violation of the zoning regulations; to give property owners a claim of title on vehicles abandoned on their property, and to require that auctioneers maintain a record of VINs & purchasers for motor vehicles sold. (Co-introduced by Councilmembers Mendelson, Ambrose, Brown, Gray, and Patterson)
20. ✓ **Bill 16-120, “Abatement of Nuisance Construction Projects Amendment Act of 2005”** (see also, emergency and temporary versions, **Bills 16-100 & 16-101**). To amend the Construction Code and the statute to provide stiffer penalties and to clarify the types of injunctive relief available to deter illegal construction, and for other purposes. (Co-introduced by Councilmembers Gray, Mendelson, Ambrose, Brown, and Graham) *Emergency adopted as Act 16-42; temporary adopted as D.C. Law 16-4; permanent adopted as D.C. Act 16-133*
21. ✓ **Bill 16-125, “Youth Protection From Obscene Video Games Act of 2005.”** To create an “entertainment” endorsement to the Basic Business License; to prohibit the sale, rental, or furnishment of obscene video (per industry ratings) games to minors in licensed retail establishments. (Co-introduced by Councilmembers Fenty, Mendelson, Ambrose, Barry, Brown, Catania, Cropp, Evans, Graham, Gray, Orange, and Schwartz) *Amended simply to authorize DCRA to provide public information about video ratings.*

22. **Bill 16-139, “Commercial Utility Tax Amendment Act of 2005.”** To benefit local businesses by eliminating the 5.75% sales tax they pay on utility purchases, partially offset by a 1% increase in the gross receipts tax on their utility bills.
23. **Bill 16-140, “Small Business Personal Property Tax Exemption Act of 2005.”** To revise the tax imposed on personal property so as to exempt the personal property of any person, corporation, or partnership with annual gross receipts of \$500,000 or less. (Co-introduced by Mendelson and Ambrose)
24. **Bill 16-144, “Uniform Child Witness Testimony by Alternative Methods Act of 2005.”** To provide procedures in taking the testimony of children in criminal, civil, or administrative proceedings by methods other than testifying in a courtroom or hearing room and in the immediate presence of a defendant or respondent, while preserving the constitutional rights of defendants and respondents.
25. **✓Bill 16-145, “Uniform Mediation Act of 2005.”** To provide for confidentiality in mediation proceedings, to establish an evidentiary privilege for mediators and participants in mediation that applies in later legal proceedings, to create an obligation of confidentiality for mediators, and to facilitate international commercial mediation in the District.
26. **Bill 16-146, “Uniform Arbitration Act of 2005.”** To enact the revised uniform arbitration act in the District of Columbia.
27. **✓Bill 16-147, “Uniform Environmental Covenants Act of 2005.”** To provide clear rules for a perpetual real estate interest, called an environmental covenant, in order to regulate the use of brownfields when real estate is transferred from one owner to another.
28. **✓Bill 16-151, “Uniform Family Support Act Amendments Act of 2005.”** To amend the Uniform Family Support Act by clarifying jurisdictional rules, to provide clearer guidance as to the redirection of support payments, to incorporate technical updates concerning the use of electronic communications, the evolution of specific agency practices and forms, and organizational changes.
29. **Bill 16-175, “Victims of Domestic Violence Fund Establishment Act of 2005.”** To establish a grant program for non-profit providers of emergency shelter to victims of domestic violence. (Co-introduced by Councilmembers Brown, Mendelson, Barry, Catania, Cropp, Evans, Fenty, Graham, Gray, Orange, and Schwartz)
30. **✓Bill 16-177, “Carver 2000 Low-Income and Senior Housing Project Act of 2005.”** (Emergency Bills 16-184 & 16-318, Temporary Bill 16-185) To provide tax exemptions and fee waivers for the Carver 2000 Low-Income and Senior Housing Project located in Ward 7. (Co-introduced by Councilmembers Mendelson and Gray) *Emergencies adopted as Acts 16-53 & 16-99; temporary adopted as D.C. Law 16-8; permanent adopted as Subtitle U of Title I of Bill 16-200, the Fiscal Year 2006 Budget Support Act of 2005: D.C. Act 16-166*
31. **✓Bill 16-178, “Real Property Tax Relief Act of 2005.”** To increase the homestead

exemption to \$60,000, to establish a calculated rate (at the rate of inflation or 5%, whichever is greater) for Class I properties, and to revise the circuit breaker (income tax credit for real property taxes) for owner-occupants and residential tenants with household incomes less than \$85,000 per year. See Bill 16-200: Subtitles N (homestead \$ \$60,000) & EE (calculated rate at 9%/8%/7% in FY 2007/2008/2009) of Title I of the Fiscal Year 2006 Budget Support Act of 2005; revised circuit breaker not adopted. *Adopted as part of D.C. Law 16-33*

32. ✓ **Bill 16-187, “Smokefree Workplaces Act of 2005.”** To create smokefree work environments in all enclosed public and private workplaces in the District of Columbia, and to establish pen-alties for the violation of smokefree workplace regulations. (Co-introduced by Councilmembers Fenty, Patterson, Mendelson, Brown, and Gray) *See Bill 16-293*
33. ✓ **Bill 16-193, “Occupational Safety and Health Amendment Act of 2005.”** To amend the District’s 1988 OSHA law to require that all workplaces (with some exceptions) be free from recognized hazards (smoking) that may cause death or serious physical harm or illness to the employee. (Co-introduced by Councilmembers Brown, Mendelson, Ambrose, Gray, and Patterson) *See Bill 16-293*
34. ✓ **Bill 16-200, Fiscal Year 2006 Budget Support Act of 2005: “Collective Bargaining Agreements Amendment Act of 2005,”** (Title I, Subtitle E) provides that no subordinate agency of the Mayor shall negotiate its own collective bargaining agreement. *Adopted as part of D.C. Law 16-33*
35. ✓ **Bill 16-242, “Homeland Security, Risk Reduction, and Preparedness Act of 2005.”** To establish a Homeland Security Program within the Emergency Management Agency; to establish a Homeland Security Commission; to establish strict liability and general and punitive damages against anyone who transports ultrahazardous materials within the District; and for other purposes. (Co-introduced by Councilmembers Patterson and Mendelson)
36. ✓ **Bill 16-279, “Office of Administrative Hearings Term Amendment Act of 2005.”** To reduce the interim appointment of administrative law judges to a period of one year at the Office of Administrative Hearings. (See also Bill 16-416) *Adopted as D.C. Law 16-83*
37. ✓ **Bill 16-280, “Public Library Gift Act of 2005.”** To establish a simple mechanism whereby the Public Library system may receive and expend gifts, monetary or otherwise; and for other purposes. *Adopted as part of Bill 16-624*
38. ✓ **Bill 16-286, “Way to Work Amendment Act of 2005.”** To create a requirement for a living wage; to create a job opportunity bank to increase job opportunities for low-income, skills-deficient residents; and to enhance the First Source Employment Agreement Program by expanding coverage and requiring performance deposits. (Co-introduced by Chairman Cropp and all Councilmembers) *Substantially amended before adoption as D.C. Act 16-335.*
39. ✓ **Bill 16-293, “Department of Health Functions Amendment Act of 2005.”** To amend the Department of Health Functions Clarification Act of 2002 to require the DoH to inspect all enclosed work places to ensure the absence of recognized hazards (e.g., tobacco smoke) that

may cause death or serious physical harm or illness to the employee. (Co-introduced by Councilmembers Patterson, Mendelson, Ambrose, Brown, Fenty, and Gray) *Adopted as D.C. Law 16-90*

40. **Bill 16-333, “Labor Requirements Act of 2005.”** To establish requirements and improve administrative procedures for contractors, subcontractors and certain other firms to ensure the use of First Source and apprenticeship programs, favoring D.C. residents; and to provide funding for pre-apprenticeship programs. (Co-introduced by Councilmember Mendelson and Chairman Cropp)
41. ✓**Bill 16-335, “Protection of District of Columbia Public Officials and Employees Act of 2005.”** To prohibit the intimidation of or interference with District of Columbia public officials and employees while engaged in or on account of the performance of their official duties and to enhance the penalties for certain crimes committed against these persons while engaged in or on account of the performance of their official duties. (Co-introduced by Councilmembers Catania, Mendelson, and Chairman Cropp) *Incorporated into Bill 16-247*
42. **Bill 16-346, “Retroactive Pay in Collective Bargaining Agreements Amendment Act of 2005.”** To prohibit retroactive pay in collective bargaining agreements, except in certain circumstances. (Co-introduced by Councilmember Mendelson and Chairman Cropp)
43. ✓**Bill 16-387, “Commission on Poverty in the District of Columbia Establishment Act of 2005.”** To establish a commission on poverty with the specific goal of reducing poverty; to evaluate existing and future anti-poverty programs in the District; and to make recommendations to strengthen and enhance the educational, economic, health and housing status of persons in poverty. (Co-introduced by Councilmembers Barry, Mendelson, Brown, Catania, Fenty, Gray, Orange, and Schwartz)
44. ✓**Bill 16-388, “Government Facility Security Amendment Act of 2005.”** To amend the Budget Support Act of 2004 to remove the requirement that the Mayor submit a reorganization plan transferring government facility security to the Metropolitan Police Department. (Co-introduced by Councilmembers Mendelson and Orange) *Adopted as D.C. Act 16-345*
45. ✓**Bill 16-406, “Criminal Background Checks for the Protection of Children Clarification Emergency Amendment Act of 2005”** (temporary is **Bill 16-407**; Congressional review is **Bill 16-576**). Amends the criminal background check requirement in D.C. Law 15-353, the Child and Youth, Safety and Health Omnibus Amendment Act of 2004, to provide that persons convicted of certain crimes are not automatically excluded from working as employees or as unsupervised volunteers of certain providers providing direct services to children or youth. (Co-introduced by Councilmembers Mendelson and Evans) *Emergencies & temporary adopted as D.C. Acts 16-179, 16-259 & D.C. Law 16-65; permanent incorporated into Bill 16-247*
46. ✓**Bill 16-416, “Office of Administrative Hearings Rental Housing Emergency Amendment Act of 2005.”** (Permanent is Bill 16-279. Second emergency is **Bill 16-548**; Congressional Review Emergency is **Bill 16-651**) To delay the transfer (from October 1,

2005 to January 1, 2006) to the Office of Administrative Hearings of the adjudicatory functions for all cases under the jurisdiction of the Rent Administrator in the Department of Consumer and Regulatory Affairs. Ultimately delayed until October 1, 2006. *Emergencies adopted as D.C. Acts 16-181, 16-246 & 16-334*

47. ✓ **Bill 16-457, “Rental Control Reform Amendment Act of 2005.”** To amend the Rental Housing Act of 1985 to repeal the provisions which allow the landlord to raise the rent ceiling of a vacant rental unit by 12% or to the highest comparable within that building, to allow the landlord to increase the rent ceiling of a vacant rental unit by an amount equal to 1% multiplied by the number of years since the last vacancy occurrence, to limit the amount of any adjustment in rent charged on an occupied unit to 10% of the current rent charged, and to limit to one per year the number of increases in rent charged. (Co-introduced by Councilmembers Graham, Mendelson, Barry, Brown, Cropp, Evans, Fenty, Gray, Orange, and Patterson) *Moved as a substitute to Bill 16-109.*
48. ✓ **Bill 16-462, “Natural Gas Taxation Relief Amendment Act of 2005.”** (See also emergency **Bills 16-439 & 16-575** and Temporary **Bill 16-440**). To amend the tax code to provide that the utility tax on natural gas is based on the number of therms delivered to consumers rather than the value of the sale. (Co-introduced by Councilmembers Catania, Mendelson, Ambrose, Brown, Cropp, Evans, Fenty, and Schwartz) *Emergencies adopted as D.C. Acts 16-186 & 16-258; temporary as D.C. Law 16-48; permanent as*
49. ✓ **Bill 16-463, “Anti-Drunk Driving Clarification Amendment Act of 2005.”** To amend the Drunk Driving Act of 1982 to revise the presumptions that shall be made based upon the amount of alcohol in a person’s blood, urine, or breath. (Co-introduced by Councilmembers Schwartz, Mendelson, and Chairman Cropp) *Adopted as D.C. Law 16-195*
50. ✓ **Bill 16-470, “Income Withholding Transfer and Revision Congressional Review Emergency Act of 2005.”** To consolidate two functions – child support income withholding and child support disbursements – in one agency, the Office of the Attorney General. It transfers child support income withholding functions from the Superior Court. The bill would also revise existing law to clarify and update income withholding requirements and procedures, fill gaps, and resolve inconsistencies that have developed through successive amendments over time to the withholding provisions. See PR 16-319 & PR 16-470 *Adopted as D.C. Act 16-200*
51. **Bill 16-495, “Menu Education and Labeling Act of 2005.”** (MEAL Act) To require restaurants which are part of a chain having 10 or more locations nationally, to provide nutritional information for standard menu items sold. (Co-introduced by Councilmembers Mendelson, Barry, and Patterson)
52. **Bill 16-496, “Large Retailer Accountability Act of 2005.”** To establish standards for responsible business practices by large retailers (30,000 square feet or more and parent company’s gross revenues total \$1 billion or more annually) by ensuring that they pay living wages, provide benefits, and respect free speech.

53. **Bill 16-512, “Income Fairness Act of 2005.”** To enact a nonresident income tax and to require the CFO to submit an analysis of the fiscal impact on the District’s budget of reducing the maximum personal income tax rate to between 4 to 7 percent upon enactment of the nonresident income tax. Enactment is subject to approval by referendum and by the Congress. (Introduced by Councilmembers Fenty, Mendelson, Barry, Brown, Evans, Graham, Gray, Patterson, and Chairman Cropp)
54. ✓**Bill 16-515, “District of Columbia Green Building Act of 2005.”** To establish a high-performance building standard to encourage the planning, design, construction, and operation of building projects that help to mitigate the environmental, economic, and social impacts of built structures in the District. (Introduced by Councilmembers Ambrose, Mendelson, Graham, and Chairman Cropp)
55. ✓**Bill 16-573, “Identity Theft Technical Amendment Emergency Act of 2006”** (Temporary is **Bill 16-574**; Congressional Review Emergency **Bill 16-687**). To establish a criminal penalty for the offense of attempt to commit identity theft. Permanent version to be included in Public Safety Omnibus Act. *Emergencies adopted as D.C. Acts 16-257 & 16-359; temporary adopted as D.C. Act 16-296; permanent incorporated into Bill 16-247.*
56. ✓**Bill 16-586, “Metropolitan Police Department Applicant Obligated Service Amendment Act of 2006.”** To authorize the Metropolitan Police Department to require candidates for employment as sworn officers to enter into obligated service agreements that require reimbursement to the District government for training costs if the employee voluntarily leaves within three years of being hired. *Renamed the “Metropolitan Police Department Amendment Act of 2006.”*
57. ✓**Bill 16-587, “Office of Police Complaints Amendment Act of 2006.”** (Emergency is **Bill 16-742**; Congressional emergency is **Bill 16-938**.) To exempt from FOIA disclosure investigatory records compiled by the Office of Police Complaints if the complaint case is active. *Emergencies adopted as D.C. Acts 16-379 & 16-xxx.*
58. **Bill 16-659, “Nursing Staffing Standards Act of 2006.”** To establish safe nursing staffing standards in certain health care facilities such as hospitals, and thereby ensure quality patient care. (Co-introduced by Councilmembers Mendelson and Patterson)
59. ✓**Bill 16-660, “District of Columbia Poverty Lawyer Loan Assistance Repayment Program Act of 2006.”** (Emergency is **Bill 16-941**; Congressional emergency is **Bill 16-1014**) To establish within the Office of the Attorney General a loan assistance repayment program to encourage law students and lawyers to practice in poverty areas of the law, thereby improving access to justice for impoverished and underserved citizens. *Adopted as D.C. Law 16-203*
60. ✓**Bill 16-688, “National Guard Operations Coordination Emergency Act of 2006.”** (Temporary is **Bill 16-689**) To direct the Mayor to enter into consultation with the Commanding General of the National Guard to establish a plan for the National Guard to assist the Special Operations Division of the Metropolitan Police Department. *Adopted as D.C. Act 16-365 (emergency) & D.C. Act 16-385 (temporary). Permanent adopted as Title III, Subtitle D*

61. ✓ **Bill 16-702, “Heating Oil Taxation Relief Amendment Act of 2006”** (See also emergency **Bill 16-738 & Temporary Bill 16-739**). To amend the tax code to tax heating oil based on the number of gallons delivered to consumers rather than as a gross receipts tax. (Co-introduced by Councilmembers Fenty, Mendelson, Ambrose, Brown, Catania, Evans, Schwartz, and Chairman Cropp) *Emergency adopted as D.C. Act 16-376; permanent incorporated into Bill 16-462.*
62. ✓ **Bill 16-705, “Drug Paraphernalia Amendment Act of 2006.”** To clarify which materials shall be considered prohibited drug paraphernalia and to create a rebuttable presumption that certain items are drug paraphernalia. (Co-introduced by Councilmember Mendelson and Chairman Cropp) *Incorporated into Bill 16-247.*
63. ✓ **Bill 16-706, “Service of Process of Police Officers Act of 2006.”** To require the Metropolitan Police Department to create a process for service of police officers. *Incorporated as part of Bill 16-586, the “Metropolitan Police Department Amendment Act of 2006.”*
64. ✓ **Bill 16-707, “Uniform Disclaimers of Property Interests Act Revision Act of 2006.”** To maximize the ability of individuals to disclaim interests in property, to enable individuals to take full advantage of tax exclusions recently recognized by the U.S. Department of the Treasury for joint owners of property, and for other purposes. *Adopted as D.C. Law 16-205*
65. **Bill 16-709, “Communications Technology Authority of the District of Columbia Establishment Act of 2006.”** To establish as an independent authority the Communications Technology Authority of the District of Columbia, to supervise the management, development, and operation of the District government’s telecommunications and information technology network. (Co-introduced by Councilmembers Orange, Mendelson, Ambrose, Barry, Evans, Gray, and Patterson)
66. ✓ **Bill 16-746, “Criminal Record Expungement Act of 2006.”** To create a process to expunge and/or seal certain criminal records in cases of actual innocence, and certain misdemeanors and felonies in the District of Columbia. *Renamed the “Criminal Record Sealing Act of 2006.”*
67. ✓ **Bill 16-788, “Retired Police Longevity Amendment Act of 2006.”** To include longevity steps for 20 years of service as basic compensation for the purpose of calculating retirement annuities for MPD officers appointed on or before February 15, 1980. *Incorporated as part of Bill 16-586, the “Metropolitan Police Department Amendment Act of 2006.”*
68. **Bill 16-789, “Condominium Warranty Bond Amendment Act of 2006.”** To enact regulations to implement D.C. Law 13-46, the “Condominium Amendment Act of 1999.” (Co-introduced by Councilmembers Mendelson and Graham)
69. ✓ **Bill 16-864, “Omnibus Public Safety Emergency Amendment Act of 2006.”** (Permanent is Bill 16-247, Congressional Review is **Bill 16-964**) To amend various statutes in the
